

# Terms & Conditions of Eutonomy's "Photo-Tech" contest for Installers and Distribution Partners

## Definitions:

1. "Organizer" - Eutonomy Sp. z o.o. sp.k. ul. Piotrkowska 121/3a 90-430 Łódź, Poland.
2. "Contestant" - each person submitting their photographs via e-mail instantly becomes a Contestant.
3. "Terms and Conditions" - regulates Contest's internal rules and policies, participation conditions, Organizer's rights and obligations.
4. "Contest" - a competition titled "Photo-Tech" which rules are regulated in Terms & Conditions.
5. "Contest Committee" - a group of people responsible for selecting the winning photographs.

## §1

### GENERAL STATEMENTS

1. Contest will be conducted through e-mail correspondence.
2. Participation in the Contest can be taken by a person who meets conditions set in §2 point 1.
3. Taking part in the Contest means sending a photography or photographs and a short message, it is also assumed that the Contestant have read and accepted Terms & Conditions.
4. Contest starts on April 1<sup>st</sup>, 2019 and ends on May 31<sup>st</sup>, 2019, 11:59pm.

## §2

### ELIGIBILITY

1. The Contestants must meet conditions listed below:
  - a. Must be at least 18 and have the ability to perform legal actions
  - b. Must read and accept the Terms & Conditions

- c. Must not be an employee of Eutonomy company
- d. Must not be a relative to an employee of Eutonomy company

#### §4 PRIZES

1. The prizes are:
  - a. 1<sup>st</sup> place – 12 euFIX adapters selected by the winner or euFRAME concealed panel (colour of the frame can be chosen by the winner from the Essential line)
  - b. 2<sup>nd</sup> place – 8 euFIX adapters selected by the winner
  - c. 3<sup>rd</sup> place – 6 euFIX adapters selected by the winner
2. Photographs will be selected according to criteria of aesthetics, creativity and installation correctness.
3. The Winners will be notified within 10 working days from the deadline.
4. In order to confirm willingness to accept the prize, the notified Winners should reply via e-mail to [competition@eutonomy.com](mailto:competition@eutonomy.com) within 3 working days from the day of sending the notification.
5. The prizes will be sent at the Organizer's cost within 15 working days from the date of the Competition's settlement to the addresses indicated by the Winners.

#### §5 DATA PROTECTION AND PUBLICITY

1. The condition of participation in the Contest is the submission of true and real personal data by the Contestants: name, surname, address, e-mail address, telephone number, necessary to deliver the prize.
2. By entering the Contest and accepting Terms & Conditions, the Contestants consent to the processing of personal data by the Organizer. The data will be processed in order to:
  - a. Conduct the Contest
  - b. Deliver the prize
3. By joining the Contest, Contestants agree that the Organizer will have the rights to publish the submitted photos on the Organizer's website, fan page on Facebook, and for other marketing purposes (e.g. folders, leaflets).
4. The Contestants, by sending photos, declare that neither he/she nor the owner of the object where the photograph was taken will protest against the publication of these photographs, nor will he/she demand an additional fee or compensation.

## §6

### CLOSING STATEMENT

The Organizer has the right to change the internal rules of Terms & Conditions, as long as it does not worsen the conditions of participation in the Contest. In particular this applies to changes in the dates of certain competition activities. In case where changes are applied, all of the Contestants will be immediately notified via e-mail.
